

Request an Increase in Cover - Special Event



- A special event allows you to increase your cover with no further questions asked about the insured person's* state of health.

You qualify for a special event increase for Life Cover, Critical Conditions Cover, and Total and Permanent Disability Cover, if;

- the insured person is 59 or younger
- your policy has a loading of no more than 50% because of the insured person's health
- you haven't claimed and aren't eligible to claim under this policy (in other words, you're not planning to claim in the immediate future)
- your payments are entirely up to date.
